And whereas prior to the execution of these presents the Founder & Managing Trustee has handed over to the Trustees a sum of Rs. 1,000/- (the receipts whereof the Trustees do hereby admit and acknowledge)

And whereas Founder & Managing Trustee and the Trustee are now desirous of declaring the Trust and of executing this Deed concerning the said sum of Rs. 1,000/- and the said project.

NOW THEREFORE THIS DEED OF TRUST WITNESSTH AS FOLLOWS:-

i. This Trust shall be known as **"THE SEESHAN'S KENNEL FOUNDATION"**

ii. The objects of the Trust are as follows:-

- a. To adopt domesticated and stray animals indie dogs

- c. To organise awareness campaign in schools and colleges to promote compassion towards stray animals
- d. To establish a Kennel to protect stray animals through feeding and health supporting.
- e. To control stray dogs and other stray animals through proper scientific Animal Birth Control Systems
- f. To conduct sports and other events for dogs and other pet animals
- g. To dedicate to maintain the integrity of our kennel

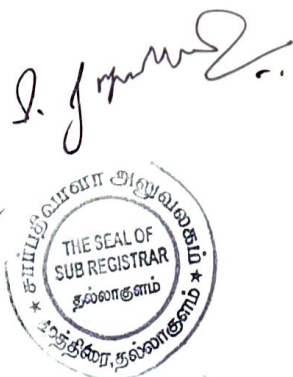

- l. To disinfect all kennels whenever the presence of an infectious or contagious disease has been confirmed in Kennels, or even suspected in Kennels, thorough disinfections of the individual kennel concerned or the whole kennel block, if "disease is wide spread, must be vigorously carried out.
- m. To de tick the blood-sucking parasites, which attach themselves to the skin for varying periods of time.
- n. To improve the health and welfare of all animals, and promote responsible animals ownership
- o. To broad and far-reaching, incorporating hereditary and health improvement campaigns for all dog and other stray animal breeds.

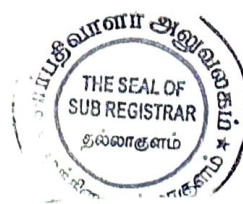


- u. To establish first aid medical centers and link up with Government health system for medical needy persons.

- pp. To conduct periodic lectures, meetings, conferences, seminars and surveys on matters of interests to National and International weaker sections of the people.

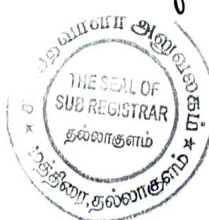

- zz. To establish and maintain research and reference libraries reading rooms, study classes, hostels and centers for a study, recreation and welfare for the benefit of the socially economically and educationally down-trodden people.
- aaa. To conduct orientation programmes for social workers on basic law of our nation in order to make them understand law of our nation.
2. The office of the Trust shall be situated at rented building 4/190, STARS VILLA, Raja Street, Thashildhar Nagar, Madurai – 625 020. or at such other places in India as the Trustees may decide upon. Branch offices of the Trust if deemed necessary shall be opened at the discretion of the trustees at one or more places in India.
3. To avail support from Ministry of Environment and Forest, Central / State Financial Institutions, Body corporate, Nationalized / Scheduled banks, co-operative Banks, other Governments / Non-Government agencies, both within India and abroad, for attainment of its objectives, with or without security of the movable/immovable properties of the trust self Help deposits, or in any form as required by the landing institution.
- a) The funds of the Trust shall be constituted from the following Initial contribution of the trustees. donations, loan raised from banks for specific purposes, contributions, Income from banks for specific purposes, contributions, Income from assets and investments, Fees and service charged collected.
- b) The funds of the trust shall be invested in the modes specified under the provisions of Sec.13 9i) (d) read with Sec 11(5) of the Income Tax Act 1961 or any other amendment made therein.

- c) The funds of the Trust will be exempted under 12A & 80 G of the Income Tax Act 1961 or any other amendment made therein
- d) The Trust will be registered under Foreign Contribution Regulation Act.
4. The Trustees shall be entitled to sell by public auction or private treaty as they may deem proper any immovable properties forming part of the Trust upon such items and conditions as they deem proper and beneficial to the Trust.
5. The trustees shall have power to raise loans or obtain advances for the purposes of the trust with or without security and upon such terms and conditions as they deem proper.
6. The Trustees shall be entitled to let out its building or portions thereof as is not required for the purpose of the Trust and also other immovable properties which form part of the Trust on such terms and conditions as they deem proper.
7. The trustees shall be entitled to appointing one trustee from amongst themselves as the Founder & Managing Trustee with such powers and upon such terms as the trustees may from time to time decide. Apart from the Founder & Managing Trustee the Trustees shall be entitled to appoint another trustee from among themselves as Financial Trustee. The trustees appointed shall at all time during their period devote either on whole time or part time basis, to the various activities of the trust and for the services rendered, they shall draw monthly allowances and other peruse as the trustees time to time determined.
8. The trustee shall be entitled to remove and replace any number of such advisory committee or reconstitute such committees from time to time.

9. Every property of the Trust, movable or immovable shall be kept in the name of the Trust.
10. The term of office of the Founder & Managing Trustee and Financial Trustee shall not exceed three years from the date of his acceptance of the Trust ship, provided however that he shall be eligible for re- appointment as trustees and the rights, powers and dirties assigned to the existing Trustee or Trustees will also be vested in the Trustees or Trustee, Jointly and severally with the surviving or continuing Trustees or Trustee. Every new trustee appointed as aforesaid shall have the same powers, authorities and divert and shall in all respect act a if he had been originally appointment trustee under these presents.
11. Whenever any Trustee resigns dies or becomes insolvent or insane or is so convicted of a criminal offices offence involving moral turpitude or desires to be discharged from or refuses or becomes unfit or incapable of acting, then in every case, the surviving or the continuing Trustee for the time being shall be entitled to appoint a Trustee in the place of such trustee becoming insolvent or being convicted.
12. Every resolution or decision of the Trustee unless unanimous shall be taken by a majority of the Trustee present and voting and in the case of equality of vote, the Founder and Managing Trustee presiding shall have a casting vote. The Trustee may pass any resolution by circulation if it is unanimous.
13. The Trustee shall be entitled to levy charge and collect such fees or subscription as they may from time to time decide for the facilities to be provided as which of its project at which of its projects and for the use of and occupation of the rooms auditorium or any other part of its buildings.

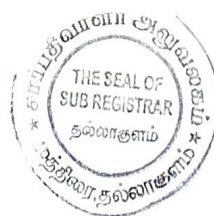

14. The Trustee shall be entitled to frame rules and regulations for the conduct of their business and for the administration of the Trust and for carrying out its objectives and for the maintenance and conduct of its project its activities and the facilities provided therein and the alter, amend or very such rules and regulations from time to time as they may deed proper. Such rules and regulations shall not been contravention of the Income Tax Act in the respect.
15. The Trustee shall not to authorize the Founder & Managing Trustee and they shall to authorize Financial Trustee to open and operate jointly an account or accounts with any one or more schedule banks in the name of the Trust if the Founder & Managing Trustee or Financial Trustee or both goes on leave, they shall authorize other existing trustee to carry out several functions and bank operations.
16. Proper accounts showing all receipts and disbursements made on account of the trustee hereby constituted shall be kept by the Trustees and the same shall be duly audited with all necessary vouchers at least once in every year by such auditor or auditors as the Trust appoints.
17. The Trustees shall have full power to compromise or compound all actions/suits and proceeding all difference and demands and to refer any dispute or difference in arbitration and to adjust settle and approve all accounts relating to the Trust Funds.
18. The Founder & Managing Trustee shall be entitled to engage such staff and servants and upon such terms as to remuneration and other connected matters as they may deem proper and to suspend, remove or dismiss any persons as employed and to make provisions for the benefit or the staff by way of provident fund, gratuity or otherwise as the Trustee may deem proper.

19. The receipt by the Founder & Managing Trustee or any other persons duly authorized by the Trustees for the monies paid in respect of Trust Fund or in respect of any monies which may otherwise become payable in the Trust or in respect of the Trust shall effectively discharge the persons or person paying the same there from or from assessing to the application thereof.
20. The Trustees for the time being under these presents shall be respectively chargeable only for such moneys as they shall respectively actually receive or receipts for the sake of conformity and shall be answerable and accountable for only their own acts, receipts, neglects or defaults and not for these of the other or others of them or for any Banker or other person with whom or in whose hands any trust money may be deposited or come for any loss unless the same shall happen through their or his own willful default.
21. The Trustee for the time being may reimburse themselves or himself or pay and discharge out of the Trust Fund all expenses properly incurred in or about the execution of the Trust or powers under these presents.
22. It is hereby declared that no benefit accrued shall ensure either directly or indirectly to the Trustees.
23. The Trustees consider that the object of the Trust will be better achieved if the Income Tax on the Trust is exempted under the Income Tax Act, in case however, a particular clause of the instrument of Trust has been inadvertently clothed in language capable of an interpretation in conflict with the relevant provisions of the Income Tax Act granting exemption, it is expressly declared that such clauses shall have restricted meaning or null and void so that the relevant Income Tax Act provisions will always have the overriding effect.

AMENDMENT DEED

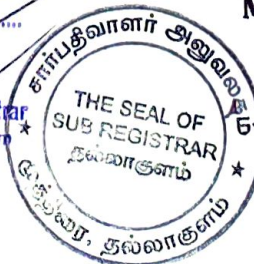

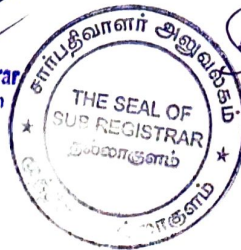

- e. The meeting of the Board shall be convened after giving at least twenty one day notice unless those who are entitled to receive notice agree to accept a shorter notice.

1. BANK ACCOUNT:

The bank account shall be opened in the name of the trust and shall be operated jointly by the Chairman/Managing trustee and financial trustee.

2. ACTIVITIES AREA:-

The activities and functions of the Trust shall be only towards charitable purpose and not for any profit motive. No activities of the Trust will be carried out anywhere outside India. The Trust should be confined within the territorial jurisdiction of India.

3. BENEFICIARY CLAUSE:-

The benefits of the objects would be available to the general public irrespective of caste creed, religion or sex.

4. UTILIZATION CLAUSE:

The Income of the Trust shall be solely utilized towards the objects of the Trust and no portion of it shall be utilized for payment to the trustees by way of profit, dividend, interest etc. Any income earned by the activities of the Trust, interest from deposits shall be used to achieve the objectives of the Trust.

5. ACCOUNTS AND AUDIT:

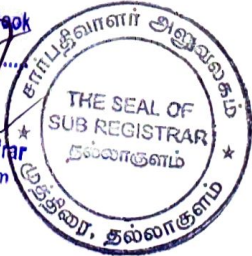

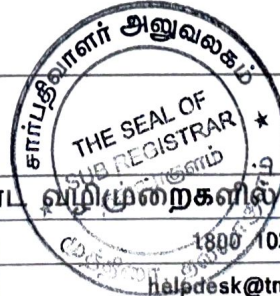

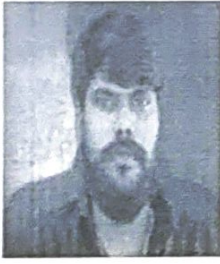
